VI. NEW GOLFERS / PLAYER DEVELOPMENT

 Our new members have been interested in playing in the Thursday Skins game. Leslie to talk with Mike about adding a 4th tee time.

- Barbara proposed having a meeting with our new golfers to discuss their experience so far with the club, to discuss various topics (i.e. pace of play, rules, scorecards, score posting, etc), and to offer suggestions for possible learning opportunities. Sue will work with Barbara on this.
- New golfer clinics Cindy proposed talking with Mike about holding a clinic on a Wednesday. \$100 for 4 participants to be paid for by the WHRLGC.

- Cindy and Leslie will work on a booklet of flights. Brenda has a template for this.
- Brenda has entered all participants in Golf Genius.
- Lightning Bolt scramble: format will be Step Aside with 1 minimum drive per player. Cindy will add scramble participants to Golf Genius. We will be playing holes 1 - 9 and winners will be announced on Tuesday afternoon.
- Leslie and Sue to find out from Mike if we can leave clubs in the carts overnight. In addition, we will ask Mike about adding longest drive and straightest drive signs as well as who can pick them up at the conclusion of the tournament.
- Sue will ask Mick Soli and Bill Peterson if they can take pictures.
